## PROJECTS



Trustee, West Chicago Environmental Response Trust (WCERT), IL

Weston serves as the Trustee for the WCERT, a U.S. Grantor Trust, established to alleviate the environmental liabilities of the Tronox, LLC. Since 2011, Weston has undertaken decommissioning and demolition (D&D) of large facilities and remediation of radiologically contaminated soil at the former Rare Earths Facility (REF), where thorium was extracted from monazite sands. Other activities comprise remediation of radiologically contaminated soil and sediments, ecological restoration of surface waters and sensitive ecosystems associated with the Kress Creek Superfund Site, and soil remediation and restoration of vicinity properties.

Weston is also developing an in situ uranium leaching technology for the treatment of source materials at the REF. With innovative and cost-effective remediation approaches and robust management and financial controls, Weston has completed all planned activities under budget every year. Weston's approach to optimize WCERT operations, address a Title X funding shortfall, and maintain schedule obligations has resulted in more than \$10M in cost savings for the Trust.

#### **Facility Support and Security Services – DOE Sites**

Since 2005, Indian Eyes, LLC (IE) has provided a broad spectrum of facility support services to DOE sites across the country, including personnel security, staffing, facility maintenance, fleet management, infrastructure upgrades, construction, and records management. These reports led to final certification of TRU and eligibility for disposal at the Waste Isolation Pilot Plant (WIPP).
