Our joint venture partnership builds upon multiple projects performed together under prime and subcontractor relationships (including secure work), as well as long-term, legacy working relationships between a number of BSGI and Weston personnel. The Bering Weston JV is currently performing over \$90M of work at five projects sites across the US and an additional two projects with Bering Straits as Prime and Weston as sole subcontractor. The JV's experience and established

working relationship, ensures low risk and high confidence of successful performance for our clients.

BSGI is an Alaska Native-Owned, SBA Certified 8(a) firm and a wholly owned subsidiary of Bering Straits Native Corporation (BSNC), an Alaska Native Corporation (ANC). BSGI is backed by BSNC, which has decades experience nationwide working with the Federal government, DCAA-approved accounting systems, over \$700M in revenue in 2024, and a bonding capacity of \$185M single and \$500M aggregate. BSGI's Mentor, Weston, is a large, 100% employee-owned national environmental and infrastructure services firm with a 65+ year history serving government, industrial, and commercial clients with gross sales of \$760M in 2024.

No \$\$ Ceiling Limit – 13 CFR 124.506(b)/FAR 19.805-1(b)

Alaskan Native Companies can be awarded sole-source DOD contracts up to \$100M with Contracting Officer approval. Contracts with unlimited dollar value can be awarded with additional levels of approval. These contracts do not require competition and are non-protestable once awarded.

Non-Protestable – 13 CFR 124.517(a)

Contracts awarded directly to an 8(a) ANC cannot be protested. The ability to fast track an important contract avoids a long, expensive, and complex procurement cycle.
