## The SBA Advantage

### 8(a) SMALL BUSINESS

As an 8(a) SDB, Tapa – Weston JV welcomes the opportunity to negotiate a sole source contract with the government. Under 13 Code of Federal Regulations (CFR) 124.506(b), sole source federal contracts may be awarded to tribally owned 8(a)-certified small businesses for up to \$25M or \$100M for Department of Defense (DoD) agencies. This CFR provision exempts contracts to 8(a) companies owned by Indian or Alaska Native tribes from the competitive lower dollar limit thresholds of other 8(a) contracts.

### NON-PROTESTABLE – 13 CFR 124.517(a)

Contracts awarded directly to an 8(a) tribally owned small business cannot be protested. The ability to fast-track an important contract avoids a long, expensive, and complex procurement cycle.
